



NACP Interim Introductory Advocacy Training Guide

The NACP Interim Introductory Advocacy Training is a NACP Pre-Approved training program that is comprised of both Office for Victims of Crime Victim Assistance Training (OVC VAT) modules **and** NOVA LMS on-demand courses.

This training was developed to provide advocates with a no cost, on-demand introductory advocacy training that meets the NACP requirements for new credentialing applicants.

This guide outlines the following:

- How to access required modules/courses
- Required documentation to verify module/course completion

1. **OVC VAT (First Required Component)**

2. NOVA LMS Courses (Second Required Component)

1. Set up your account in NOVA's LMS, Learn Upon, by [clicking here](#) or by or copy/paste the following URL into your browser: https://novatraining.learnupon.com/users/sign_up and following the instructions provided.
2. Register for the NACP Interim Introductory Advocacy Training by [clicking here](#) or copy/paste the following URL into your browser: https://novatraining.learnupon.com/store/93823-nacp-interim-introductory-advocacy-training?is_lp=1

NOTE: you will be required to add the training to your cart and proceed to checkout, even though there is no cost associated.

3. The Training should now appear on your dashboard and be available for completion.

4. Submitting Training Documentation

Accepted training documentation must be submitted altogether when you submit your digital credentialing application.
